StarMed Specialist Centre "SpotTheStarMed" Terms & Conditions

1. Participation

- (a) By participating in the "#SpotTheStarMed" contest ("Contest") organized by StarMed Specialist Centre Pte. Ltd. ("StarMed" or "Organizer"), Contestants agree to be bound by these terms and conditions ("Terms") and all amendments, additions, replacements and modifications hereto as may be made from time to time by the Organizer in its own absolute discretion.
- (b) For the purposes of these Terms: (i) "Contestants" means persons who participate in the Contest and who have fulfilled all the requirements of Clause 2 (Eligibility) and includes Younger Contestants; (ii) "Prospective Contestants" means persons who wish to participate in the Contest but have not fulfilled all the requirements of Clause 2 (Eligibility); (iii) "Younger Contestants" means Contestants under the age of 18 years; and (iv) "Prospective Younger Contestants" means Prospective Contestants under the age of 18 years.

2. Eligibility

- (a) Prospective Contestants must complete all the steps listed under Clause 4 (How to participate) within the Contest Period (as defined below).
- (b) Prior to their participation in the Contest, Prospective Younger Contestants must obtain from his/her parent or legal guardian: (i) their consent for the Prospective Younger Contestants to participate in the Contest; (ii) their acceptance of these Terms; and (iii) their agreement to take responsibility for: (1) the Prospective Younger Contestants' actions; (2) any charges associated with the Prospective Younger Contestants' use of any of the content provided, if any; and (3) the Prospective Younger Contestants' acceptance and compliance with these Terms.

5. Personal information and privacy

7. Winners

9. Rights of the Organizer

10. Liability & Responsibility

- (a) Contestants shall assume full liability and responsibility in the event of any liability, mishap, injury, loss, damage, claim or accident resulting from their participation in this Contest, redemption and/or usage of the Prizes.
- (b) All costs, fees and/or related expenses incurred during their participation of this Contest and/or during the redemption of the Prizes are the sole responsibility of the Winner(s) and/or Contestant(s).

11. Severability

The invalidity or unenforceability of any of the provisions in these Terms shall not adversely affect or impair the validity or enforceability of the remaining provisions of these Terms.

12. Variation

- (a) The Organizer reserves the right to terminate the Contest for any reason, without notice, at any time.
- (b) The Organizer may, in its sole and absolute discretion, by notice through email or by such other method of notification as the Organizer thinks fit, vary these Terms. Such variation shall take effect on the date specified by the Organizer which shall not be less than 7 days from the date of the notice.
- (c) Participants who do not wish to accept the variation of the Terms, shall withdraw from the Contest by providing written notice of their withdrawal to the Organizer. Participants who do not provide such written notice of withdrawal are deemed to have accepted the variation of the Terms.

(d) For the avoidance of doubt, the Organizer's right to vary these Terms in the manner aforesaid may be exercised without the consent of any person or entity who is not a party to these Terms.

13. Additional Terms

- (a) This Agreement shall be governed by, and construed in accordance with the Laws of Singapore and the Contestants hereby submit to the exclusive jurisdiction of the courts of Singapore.
- (b) A person or entity who is not a party to these Terms shall have no right under the Contracts (Rights of Third Parties) Act (Chapter 53B) of Singapore or other similar laws to enforce any of these Terms, regardless of whether such person or entity has been identified by name, as a member of a class or as answering a particular description.
- (c) In the event of any breach of these Terms, any failure or delay by the Organizer to enforce these Terms or its rights hereunder shall not constitute a release or waiver of these Terms or its rights, nor shall any single or partial enforcement of the Terms or the Organizer's rights preclude any other or further enforcement of the same by the Organizer. The Organizer's rights under these Terms are cumulative and not exclusive of any rights or remedies provided to it by law.
